More on antitrust damages and Competition Law

1. The Federal Law on Economic Competition (FLEC) states:

*“Article 36. To determine penalties the Commission should take into account infringement’s gravity, **caused damage**, signs of intentionality, defendant’s market share; size of the affected market; duration of the conduct or concentration and defendant’s recidivism or previous conducts as well as its economic strength.” (Emphasis added.)*

2. Some recent decisions of the Federal Competition Commission (FCC) wherein penalties have been imposed for antitrust infringements illustrate that the monetary amount of the sanction is arrived at following due discussion of each one of the elements comprised in FLEC’s Article 36.¹
3. Out of FCC’s public documents one cannot identify if the authority carried out a **quantitative** assessment of the “caused damage” as we can only read **qualitative** considerations.
4. In the forum **“Mexico before the crisis: What to do for achieving growth?”** the FCC’s head advocated for a rise in legal penalties.²
